I. One WASH M&E System Development

- Strengthening and use sector systems (HMIS, EMIS, IBEX etc) with sharing of data as per the MoU
- Updating of the NWI-1 to meet new KPI, and introduction of mobile-based data collection
- Ensure web-based availability of WASH data
- Facilitate more comprehensive OOWNP reports
- Collaborate with global initiatives to ensure alignment with SDGs
- Improvements in systems and processes will need the engagement of all to roll-out and utilise



II. CSOs' Water & Sanitation Forum Progress Report

- CSO's continue to work with Government to increase their accountability
- More regulation is needed to increase visibility of CSOs' currently not reporting through WSF
- Disaggregation of CSOs' performance against national target, individual CSOs and donors support
- CSO's planning and reporting needs to be incorporated into ONWP plans and reports



III. Water Quality Monitoring Program

- Strengthen water quality monitoring indicators and related systems in MoH and ONWP
- Establish and strengthen regulatory enforcement of water quality testing and reporting
- Operational budget for water quality testing need to be increased



IV. Hygiene and Environmental Health Monitoring & Evaluation

- Establish Working Group on H&EH Monitoring
- Alignment of sanitation and hygiene targets, indicators and definitions
- Develop practical guideline to support gathering of data, analysis and reporting of H&EH indicators
- Ensuring appropriate resources are allocated to the monitoring by MoH and One WASH National Program



V. Knowledge Management

- Develop WASH sector knowledge agenda based on needs and gaps
- Strengthen knowledge creation and dissemination platforms at both National and Regional Levels
- Build capacity of leadership and practitioners on the concept of knowledge management
- Allocate sufficient budget to support knowledge management activities



VI. Urban Utility Performance Benchmarking

- Build capacity of utilities to improve data quality
- Incentivize utilities to gather and report data, through strong feedback mechanism
- Establish accountability mechanism to ensure timely delivery of data and reports
- Mainstream Performance Benchmarking into wider WASH sector M&E system
- Establish data verification and assurance mechanisms
