Undertaking # 1: Implementation of One WaSH Program as per the WIF

Progress to Date

- One WaSH Program Document with annual breakdown of the Plan and budget prepared.
- POM for the Consolidated WaSH Account implementation under preparation.

Outstanding Activities

- Update UAP II based on the results of 2003 EFY NWI, EMIS and HMIS indicators.



Undertaking # 2: implementation of Signed MoUs at all levels

Progress to Date

- MoU Disseminated at all levels.
- Most regions adapted and signed Regional MoUs based on the federal MoU.
- WaSH plans approved

Outstanding Activities

- Strengthen WaSH Coordination at Federal, Regional and Woreda levels and establish WaSH PMUs at each Ministry and Bureaus



Undertaking # 3: Ensuring the Functionality of WaSH services

Progress to Date

- Urban water O&M Manual prepared
- Rural water Operation and Maintenance Management Manual for point water schemes prepared
- Sanitation Marketing Guideline prepared

Outstanding Activities

- Development of National RWS O&MM Strategic Framework and Generic O&MM manual (ongoing)
- Make WASHCOs legalization to take place in practise



Undertaking # 4: Establishment of robust Monitoring and Evaluation system

Progress to Date

- NWI 2003 EFY data – released in MIS website
- Somali Inventory started
- 2012 High Level Commitments monitoring system established
- One JTR-8 conducted

Outstanding Activities

- Scaling up the WASH MIS from pilot woredas
- Improve the functionality of WASH MIS
- Prepare the NWI updating strategy and plan with budget



Undertaking # 5: Development of water and improved Sanitation safety Procedures, capacity and processes

Progress to Date

- Monitoring for Safe Water Program started with 2 utilities and 2 regional health labs
- RWS water safety plan capacity building carried out with CSOs and COWASH and some pilot WSPs prepared
- RWS water safety plan training material preparation I progress
- WHO launched project on *“Building adaptation to climate change in health in Ethiopia through resilient WASH”*

Outstanding Activities

- National level plan to support regions on water and improved sanitation safety management

Major JTR 8 findings

- The start-up of One WASH needs urgent awareness creation and capacity building in Regions'
 - Organizational development
 - WASH M&E development and updating
 - Coordination structure establishment
- Availability of Regional Government Funds for One WASH implementation not confirmed



Major JTR 8 findings

- Urban sanitation status is very low
- Coordination, planning and monitoring of urban sanitation is very low
- Urban sanitation priority is very low and budgets allocated for urban sanitation are almost nil
- Organizational structures of towns do not address urban sanitation
- Urban sanitation facilities are poor and disposal sites are no to standard



Major JTR 8 findings

- Agriculture is implementing massive household agricultural wells plan.
- Coordination with Self Supply planning and implementation with Agriculture needs to be strengthened
- Need to strengthen the linkage with the existing MFIs and making SS credit provisions
- Rushing for records of latrines by skipping or incomplete actual process of CLTSH lead to backing to the OD
